State Water Holding Polish Waters Regional Water Management Authority in Wrocław (PGW WP RZGW in Wrocław) made the **DRAFT LAND ACQUISITION AND RESETTLEMENT ACTION PLAN** for the Component 1 - *Flood Protection of the Middle and Lower Odra*, Subcomponent 1.B – *Flood Protection on the Middle and Lower Odra*, Works Contract 1B.7 - *WFS Widawa – the rebuilding of the flood management system of the communes and municipalities Czernica, Długoleka, Wisznia Mała and Wrocław* (hereinafter called **DRAFT LAND ACQUISITION AND RESETTLEMENT ACTION PLAN**) available for inspection to all interested people and institutions.
